Q1. Lot 1 and Lot 3 have similar materials as indicated on the table below, is this not a duplication?

A 1. **YES, it is. Cesvi reserve the right to buy the 2 items from the most successful bidders for either Lot 1 or Lot 3.**

Q2. What is the diameter and length of the copper earth rod required?

A 2. **Diameter is 16mm and 1,2m length**

Q3. Please advise order of preference between Bonox and Field fence?

A3. **Field fence is the preferred one, then Bonox as an option**

Q4. If we submit our tender on all 4 lots, but competitive in one, or two lots only, would we then be considered for supplying for those lots we are competitive in?

A4. **Correct**

Q5. The requested Z28 Joules Energizer refers to a model brand name called JVA. Is this correct?

A5. **28 Joules is what is required of any brand of Energizers that you specialize in as an authorized dealer.**

- Q6.** With regards to delivery to site. You stipulated that Lot 3 can be transported to your Beit Bridge warehouse. Will Cesvi then dispatch the goods to the relevant sites or is it up to the supplier?
- A6.** **Cesvi will dispatch to the sites when needed.**
- A7.** Do you have undercover storage at the 4 sites or is it open to the weather elements?
- A7.** **Small undercover storage is available while for the big items (i.e. treated gum poles) the storage is outside.**
- Q8.** You stipulated that you need security system for the energisers, what kind of security did you have in mind. For example, a lockable box perhaps?
- A8.** **Not only the energizer but the entire power-supply unit need to be secured. A box to secure the energizer is an option but not limited to that**
- Q9.** For the solar panels, you didn't specify if you need it mounted on stands/roof/poles
- A9.** **The installations need to be stand alone since not all the sites offer the same facility. It is up to the bidder to propose the most suitable solution.**
- Q10.** Do you have backup electricity on site for the fence to be electrified during overcasts. OR do you need a battery pack for this too?
- A10.** **The power system is a stand alone since not all sites are supplied with electricity.**
- Q11** Can I DHL the documents directly to Cesvi via DHL or would I still need a representative?
- A11.** **DHL direct to Cesvi is okay and it is not a requirement to have a representative. As per Art 6 of the tender dossier, postal delay is not an acceptable excuse for a late submission.**
